# Legal Matters

<u>Prohibition of Discrimination</u>: RSVP and/or the Volunteer Station will not discriminate against RSVP volunteers or in the operation of its program on the basis of race, color, national origin, sex, sexual orientation, age, political affiliation, religion, or individuals with limited English proficiency, or on the basis of disability, if the volunteer is a qualified individual with reasonable accommodation.

Volunteers may not engage in political or electoral activities, voter registration, voter transportation to polls, or efforts to influence legislation. Volunteers may not give religious instruction, conduct worship services, or engage in proselytizing as part of their service.
